

**UOB Kay Hian “UTRADE Edge Account” Promotion  
1 July 2015 to 30 June 2016**

**Terms and Conditions**

1. The UOB Kay Hian (“UOBKH”) “UTRADE Edge Account” promotion (“Promotion”) will be held from 1 July 2015 to 30 June 2016. Customers who trade the Singapore market using their UTRADE Edge Account will only be charged 0.12% commission or a minimum commission \$12 per trade, whichever is higher, during the promotion period. (This commission does not include other fees such as clearing fee, SGX trading fee and GST.)
2. The following persons will be eligible for this promotion:
  - a. UOBKH customers who have an existing UTRADE Edge Account (for clarity, there is no need for existing UTRADE Edge Account customers to apply for / enroll in this promotion); and
  - b. New and existing UOBKH customers who are opening a new UTRADE Edge Account.
3. Please note that eligible UTRADE Edge Account will not be entitled to any other UOBKH promotions that are running concurrently for the duration of this promotion.
4. After this promotion period, i.e., from 1 July 2016, the commission chargeable for UTRADE Edge Account will revert to 0.18% or \$18 minimum per trade whichever is higher.
5. All customers will continue to be bound by UOBKH Master Trading Agreement and the terms and conditions of any other agreement(s) that the respective customers have entered into with UOBKH.
6. New UTRADE Edge Account opening may be done at UOBKH at 8 Anthony Road #01-01 or any UOBKH Investor Centres. Alternatively, the new UTRADE Edge Account application form may be submitted on behalf of the customer by a UOBKH Trading Representative after it has been duly completed. UOBKH reserves the right to reject the opening of the new UTRADE Edge Account, and the participation in this Promotion, if the UTRADE Edge Account application is incomplete.
7. UOBKH reserves the right, in its absolute discretion, to disqualify the UTRADE Edge Account customer for any reason whatsoever, including upon the occurrence of the following:
  - a. The customer failed to pay UOBKH for his/her executed trade(s) and/or that he/she has outstanding payment to UOBKH during the Promotion period.

- b. The customer is not in good standing. If the customer's account has been suspended temporarily or terminated due to any reason, the customer will be disqualified from this Promotion.
8. UOBKH reserves the right to terminate or suspend this Promotion for any reason whatsoever.
  9. UOBKH reserves the right in its absolute discretion to terminate, vary, delete or add to any of these terms and conditions, at any time without prior notice and without having to disclose any reason therefore and without any payment or compensation whatsoever.
  10. The decision of UOBKH on all matters relating to the Promotion is final, conclusive and binding on all UOBKH customers and no correspondence will be entertained. In the event of any inconsistency between these terms and conditions and any marketing material relating to this Promotion, these terms and conditions will prevail.
